Minimum Qualification for Appointment to the post of Assistant Professor in Colleges As per UGC Regulations, 2018 and G.R. Dated 14th Nov.2018 and 8th March 2019.

i.A Master's degree with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.

ii. Besides fulfilling the above qualifications, the candidate must have cleared the Naional Eligibility Test (Net) conducted by the UGC or the CSIR or a similar test accredited by the UGC, like SET or who ar or have been awarded a Ph.D.Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET.

Provided the candidates registered for the Ph.D.programme prior to July 11,2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D.candidates shall be excempted from the requirement of NET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/College/Institutions subject to the fulfillment of the following conditions.

a.The Ph.D.degree of the candidate has been awarded in regular mode only;

i.Quacquarelli Symonds (QS);

ii.The Times Higher Education (THE) or

iii.The Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai)

*A relaxation of 5% shall be provided (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19th September,1991.

*A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's Level shall also be considerd valid.

*A relaxation of 5% shall be allowed at the Bachelor's a well as the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes(OBC) (Non-cremay Layer) Differently-abled (a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, Leprosy cured, dwarfism, acid −attact victims and muscular dystrophy; (d) Austism, intellectual disability, specific learning disability and mental illness; € Multiple disabilities from
